Procedure


Care must be taken when installing this accessory to ensure damage does not occur to the vehicle. The installation of this accessory should follow approved guidelines to ensure a quality installation.


These guidelines can be found in the "Accessory Installation Practices" document.

1. PREPARATION

- (a) Open package and check part for damage and kit contents.
- (b) Remove any stored items and debris from trunk area.
- (c) Place vehicle protection over the rear bumper.

2. INSTALL THE CARGO TRAY

- (a) Place Cargo Tray in trunk area with logo towards the rear of the vehicle and facing up. (Fig 2-1)
- (b) Grasp the tray by the rear and fold in the sides sufficiently to slide it into the rear compartment. After installing the tray, ensure all of the edges are pushed down against the floor. (Fig 2-2)

3. COMPLETE THE INSTALLATION

- (a) Remove the vehicle protection.
- (b) Close the trunk door.
