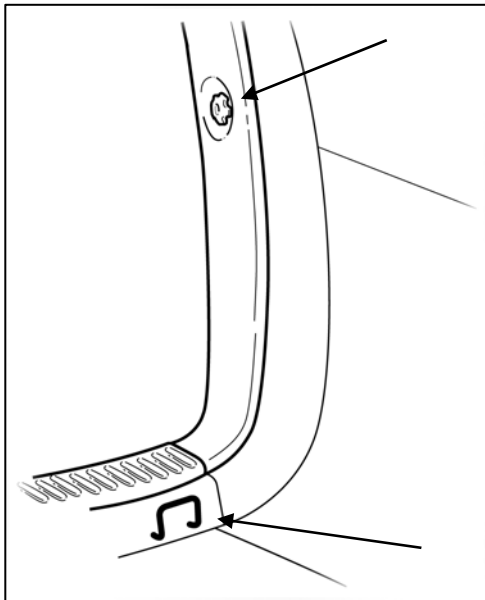

### 1. Installation of Cargo Net

- (a) Open the rear cargo door and locate the anchor points on the driver side of the vehicle. (Fig. 1-1)

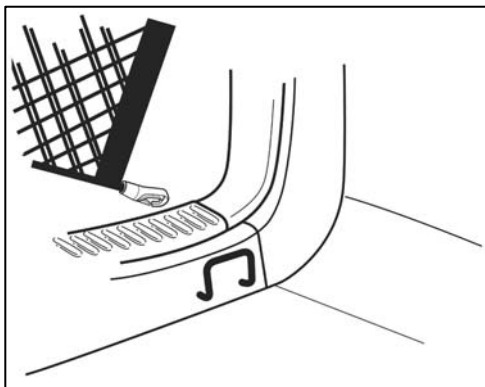

- (b) Orient the net so the pull-tab is facing towards the rear of the vehicle and install the bottom hook over the driver side lower D-ring as shown. (Fig. 1-2)

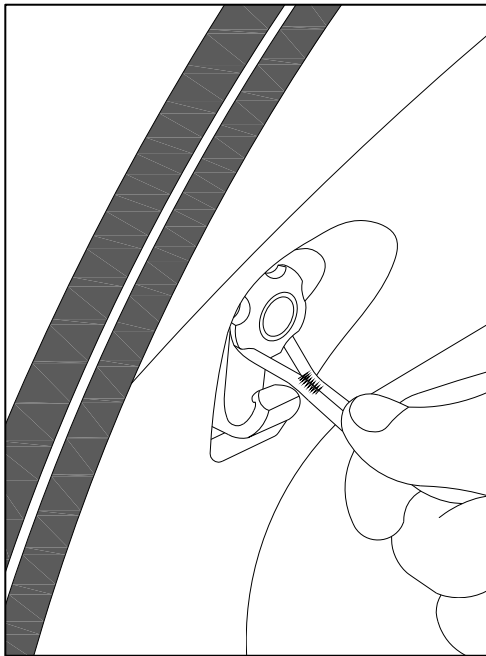

(c) Install the upper bungee loop over the driver side anchor as shown. (Fig. 1-3)

(d) Repeat steps 1(b) & 1(c) for the passenger side of vehicle.

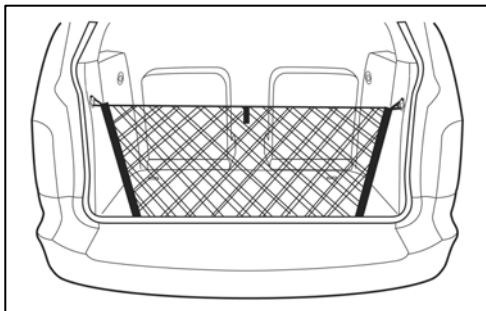

(e) Completed assembly as shown. (Fig. 1-4)

Checklist - these points **MUST** be checked to ensure a quality installation.

Check:

Look For:

Accessory Function Checks

- Correct orientation of net and pull tab
  
- Confirm the net is attached properly to the anchor points in the vehicle.

Make sure the net's plastic pull tab is facing rearward.

Make sure the net hooks are attached to the lower D-rings and the loops are attached to the anchors at the top.

Vehicle Function Checks

- Rear cargo door.

Rear cargo door should open and close freely without interference from cargo net.
